

**MINUTES OF THE 110TH SESSION OF THE SYNOD OF THE DIOCESE OF RUPERT'S LAND**  
**September 30 -- October 2, 2010**

**1ST SITTING, THURSDAY EVENING September 30, 2010** – St John's Cathedral

The 110<sup>th</sup> Session of the Synod of the Diocese of Rupert's Land opened with a service of Holy Communion. During the service Mrs. Heather Birtles, Mr. Jim Warrener, and The Rev. Bill Blackburn were awarded the Order of Rupert's Land for their contributions to the Diocese. The Rev. Donna Joy and The Rev. Barry Bear were licensed and installed as Canons of the Cathedral Chapter.

In his Address, Bishop Phillips spoke on the theme of 'Making Paths in the Desert', but began by giving thanks for those who have left us, remembering especially Bishop Patrick Lee, and mourning the disestablishment of the Parish of St Catherine's, Birds Hill.

The Rev. Canon Rick Condo, Interim Priest at St. John's Cathedral, made announcements. At the conclusion of the service a reception was held in the John West Hall.

Mr. George Campbell, chair of Rupert's Land Aboriginal Circle, reported on the Rupert's Land Aboriginal Circle [RLAC]. Rupert's Land Wechetowin Inc., chaired by Sylvia James, has continued its work as a stand-alone charitable organization after the departure of the Aboriginal Mission Developer.

The way forward for RLAC is unclear. A video message from the National Indigenous Bishop was shown. The Rev. Barbara Shoomski introduced a 'blanket exercise', a graphic illustration of First Nations-European history. Gifts of moccasins were presented to Bishop Phillips, The Ven. Godfrey Mawejje, Ms Diane Skalenda, and The Rev. Canon Henry Falconer for the Rev. Canon J. Ronald McCullough.

1. Repudiate and renounce the Doctrine of Discovery as fundamentally opposed to the gospel of Jesus Christ and our understanding of the inherent rights that individuals and peoples have received from God;
2. Request that our diocesan bishop, as requested by our General Synod of the Anglican Church of Canada, cause this declaration to be proclaimed in every parish;
3. Commit to undertake a review of our Diocese's policies and programs with a view to exposing the historical reality and impact of the Doctrine of Discovery and eliminating its presence in its contemporary policies, program, and structures;
4. Encourage all members of the Diocese to seek a greater understanding of the Indigenous Peoples within Canada and to support those peoples in their ongoing efforts for their inherent sovereignty and fundamental human rights as peoples to be respected by understanding the reality that we are all Treaty People;
5. Request that our Bishop take the following actions:
  - a) Inform all municipal, provincial and federal representatives within our diocesan boundaries and the Government of Canada of this decision and request that they conduct a similar and equivalent review of historical and contemporary policies that contribute to the continuing colonization of Indigenous Peoples,
  - b) Write to Queen Elizabeth II, requesting that her Majesty disavow, and repudiate publicly, the claimed validity of the Christian Doctrine of Discovery, and
  - c) Share this declaration with the United Nations.
