Temporality Act: 2 Incorporation: The incumbent and churchwardens of each parish and of each mission in the Diocese of Rupert's Land, erected, formed or established and organized in accordance with the constitution and canons of the synod of the diocese within which such parish is situate, are constituted a corporation under the name "The Anglican Church of Canada, Parish (or Mission) of __ within the Diocese of __", giving the particular name of the parish or mission and the name of the diocese in which it is situated.

Canon 21.1: In every parish there shall be two churchwardens selected from the communicants, one to be appointed by the incumbent and one to be elected by the parishioners, both of whom shall be ex officio members of the Vestry. Deputy churchwardens may be appointed or elected, as the case may be, to assist the churchwardens in the discharge of their duties. The parishioners shall determine whether or not the deputy churchwardens shall be ex officio member of the vestry.

Please note that deputy wardens cannot sign legal documents for the parish.

- 99 member or less may elect 2 lay delegates and substitutes for each
- 100-300 members may elect 3 lay delegates and substitutes for each
- more than 300 members may elect 4 lay delegates and substitutes for each
